LAW & JUSTICE REVIEW WRITING AND PUBLICATION RULES

(1) Articles to be published in the journal must comply with the following writing and publication rules:

- a) The journal publishes peer-reviewed articles in English, German, and French.
- b) The journal is published twice a year (in January and July).
- c) Articles submitted to the journal must not have been previously published or submitted for publication elsewhere. If previously published, the copyright must belong to the author.
- d) The responsibility for the language, scientific content, and opinions expressed in the articles lies with the author(s).
- e) Articles must be submitted to lawandjusticereview@taa.gov.tr.
- f) Articles must comply with international standards for scientific publications and writing formats
- g) Articles must include a Title of no more than 14 words, an Abstract between 150–250 words, and Keywords of 3–8 words. Numbering must not be used for the sections “Title, Abstract, Keywords, Introduction, and Conclusion.” The Title, Abstract, and Keywords must be provided in the language of the article as well as in Turkish and English.
- h) The 4th edition of the OSCOLA citation style must be used for in-text citations and references, and the footnote system is preferred.
- i) The main text and bibliography must be written in 11-point font, footnotes in 9-point, with 1.0 line spacing, using Times New Roman. Text must be justified, and 2.5 cm margins must be left on all sides of the page.
- j) Articles, including references, must be no fewer than 3,000 words and no more than 12,000 words.
- k) Yazarın akademik unvanı, adı ve soyadı, baş harfleri büyük olmak üzere makale başlığının altında ortalı olarak yazılmalıdır. Yazarın çalıştığı yer ismi ile elektronik posta adresi, adı ve soyadına ilişkin dipnotta belirtilmelidir.
- l) Authors will be notified by email whether their articles are accepted for publication.
- m) Payments for authors and reviewers, including royalties and review fees, will be made after the journal is published in accordance with Article 23 of the Justice Academy of Türkiye Publication Regulation. 20% of the author’s royalty for an article that passes peer review is paid to reviewers.
- n) Authors whose articles are published in the journal will receive two free copies of the journal.
- o) The copyright of all articles published in the journal belongs to the Justice Academy of Türkiye. Articles cannot be published elsewhere without proper citation.
